Secretary's Report:

A motion to accept the minutes as read from the December 4, 2018 meeting was made by Frank Cavallo, seconded by Dick Speer; the motion was passed unanimously.

Treasurer's Report:

First Light has indicated it will be assessing the lake in the proximity of the Shepaug Dam. A sign warning of restricted passage, supported by cable attached to trees, has been down for a good part of the year. First Light is looking at alternative methods to support the sign.

A draft of the First Light Shoreline Management Report was circulated.

Grants:

Dick Speer mentioned the grant application for First Light will be submitted in March. The LZA will request \$15,000.00 this year, an increase of \$5000.00 from last year, to supplement the cost of additional chemical weed treatments planning to be made in 2019/2020.
